1. This Invitation for Bid follows the General Procurement Notice for this Project that appeared in Development Business on 09 March 2017.
2. The Government of India has received financing from the World Bank towards the cost of National Hydrology project and it is intended that part of the proceeds will be applied to eligible payments under the contract for which this invitation for Bids is issued.

The Executive Engineer, Gauging division No-2, Bagalkote, Karnataka-587103. office land Ph No 08354-297367 e-mail: cegdbgk@gmail.com now invites tenders through e-procurement platform online from the time and date of opening of schedule up to the time and date of closing of bid submission from eligible bidders for The Supply, Installation, Testing, Commissioning and Maintenance of RTDAS for Hydrological Information System of 16 Automatic Weather Station (AWS) & 237 Telemetric Rain gauge stations (TRG) with Telemetry System under

Yermarus Circle (Bagalkot, Kalburgi & Dharwad divisions)in Karnataka and integrate with Data Center located at Bangalore, Karnataka.

4. Bidding will be conducted through the National Competitive Bidding (NCB) procedures agreed with World Bank. The bidding is open to all eligible bidders as defined in the Bank's Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 of the Guidelines setting forth the World Bank's policy on conflict of interest.
5. Bidding documents are available online on <https://eproc.karnataka.gov.in/eportal/index.seam>. Bidders will be required to register in the website, which is free of cost. The bidder would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated. The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit online transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.

Bidders are required to obtain Digital signature from designated firms (available on e-proc. Portal and then register with the Government of Karnataka e-procurement platform and submit bids by using their user ID and Digital Signature. Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <https://eproc.karnataka.gov.in/eportal/index.seam>.
7. Bidders must provide Bids security specified in the e-portal & shall be paid online, through <https://eproc.karnataka.gov.in/eportal/index.seam> accordingly. Any bid not accompanied by an acceptable bid security & not secured here of shall be rejected by the Employer as non responsive. The bid security have to be valid for 45 days beyond validity of bid. The bids must be submitted online on Karnataka e-procurement platform on or before the date and time for receipt of bids, and the "Technical Part" of the bid will be opened online on the specified time and date for opening of bids, as given above. The "Financial Part" shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the

- bids will be opened on the next working day at the same time. The electronic bidding system would not allow any late submission of bids.

Bids along with necessary enclosures must be uploaded to the web site <https://eproc.karnataka.gov.in/eportal/index.seamas> per bid document and bids will be opened at the specified venue on the stipulated date and time, in the presence of the bidders or their authorized representatives who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
 9. The bidders are required to submit (a) cost of bid document (b) bid security; and (c) original affidavit regarding correctness of information with bid document on e-portal only.

A pre-bid meeting will be held on 11-04-2022 11:30 am through Video Conference (Link will be shared to all bidders who have furnished their mail address) to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITB Clause 7.1 of 'Instructions to Bidders' of the bidding document.
